AWARDS

Membership in the TCAR Honor Society is awarded to the TCAR members who meet the requirements on an annual basis.

Special recognition will be given to TCAR Honor Society members who maintain membership for five of seven consecutive years.

Special recognition will be given to TCAR Honor Society members who maintain membership for ten of twelve consecutive years.

POINT QUALIFICATION

A minimum of 260 points are required in order to be awarded or maintain membership in the TCAR Honor Society. A member accumulating 360 or more points during any given Qualification Period will be awarded Sterling Honor Status within the TCAR Honor Society.

QUALIFICATION PERIOD

The qualification period is from September 1st 2019 through August 31st 2020 6:00PM.

Applicants may not have been found in violation of the Code of Ethics nor in violation by the Utah Division of Real Estate for the last five years. Applicant must have an active real estate license and be a member of the Tooele County Association of REALTORS®.
